



## Bequests - Gifts by Will

Children Without Borders provides the following charitable bequest clauses for your assistance. These sample clauses are intended only as illustrations and we highly recommend that any person considering the inclusion of clauses of this type in his or her Will should discuss with his or her own legal advisor the specifics of his or her situation.

### Percentage Gift

Should you wish to leave a portion or share (e.g., 20%) of your estate to help conquer cancer, your lawyer can use the following wording:

“I direct my trustees to transfer \_\_\_\_\_ percent (or share) of the residue of my estate to the **Children Without Borders** to be used for its general purposes.”

### Remainder or Residue Gift

You may wish to leave the remainder or residue of your estate, after paying debts and other bequests, to ensure that cancer will be beaten. If so, the following wording is appropriate:

“I direct my trustees to transfer the residue of my estate to the **Children Without Borders** for its general purposes.”

### Specific Gift

When your bequest is to be a specific amount of money or specific asset, for the fight against cancer, use one of the following clauses:

“I direct my trustees to deliver, pay or transfer the sum of \$ \_\_\_\_\_ to the **Children Without Borders** for its general purposes.”

or

“I direct my trustees to deliver, pay or transfer [identify the personal property to be given, e.g., 500 shares of XYZ stock...] to the **Children Without Borders** for its general purposes.”



## Designated Gifts

If you wish to leave a bequest in your Will and ensure that the important work of children's education continues, you may direct your bequest to one of the strategic objectives or priorities of the Children Without Borders. If it is your intention to designate your bequest for a specific purpose, please contact Children Without Borders in advance to ensure your gift can be used as intended.

Since needs change over time, the sample wording below helps to allow us to comply with donor wishes easily and allows flexibility for future shifts in research or program requirements:

"I direct my trustees to transfer the sum of \$ \_\_\_\_\_  
(or \_\_\_\_\_ percentage share of my estate) to **Children Without Borders**  
to be used for the following purpose(s)  
\_\_\_\_\_."

In the event that circumstances make the specific use of this gift no longer practical or desirable, the Board of Directors of Children Without Borders is hereby authorized to make changes in its use consonant with the spirit and general intent of the gift."

**Please note:** If you wish to designate your bequest to a specific purpose, we ask you to contact us prior to completing your Will to ensure your gift intentions can be met.
